



Electronic Vote of the 2016-2017 Executive Committee June 9, 2017

The 2016-2017 Executive Committee members, International President, Mike Storkey, DTM; International President-Elect Balraj Arunasalam, DTM; First Vice President Lark Doley, DTM; Second Vice President Deepak Menon, DTM; and Immediate Past International President Jim Kokocki, DTM, ratified by unanimous electronic consent culminating on June 9, 2017, International President-Elect Arunasalam's proposed appointments of members to the 2017-2018 International Leadership Committee (ILC).
